

Terms of Use
For T.O. Student Tutoring-Project Volunteer
Effective January 1st, 2010

You agree to the terms and conditions outlined in this Terms of Use Agreement with respect to T.O. Student Tutoring. This agreement constitutes the entire and only agreement between T.O. Student Tutoring and you, as an individual or group, and supersedes all prior or contemporaneous agreements, representations, warranties, and understandings with respect to T.O. Student Tutoring and its online entities.

I. Copyright

ToStudentTutoring.com ("web site") is a copyright work specifically for use by T.O. Student Tutoring and its entities, which includes the layout, graphic work, logo, and other trademark or copyright entities. Its use is only for the use of the host party, and/or authorized personnel. Use of any of its contents is only permitted by formal written indication from an approved T.O. Student Tutoring administrator. Additional terms of use policies are stated in addition to understood and prior associated policies, and failure to abide by these policies, without exception, will include legal prosecution and revocation as permitted by local and national governance to the fullest extent. II. Volunteer Information and Agreement

- a. Tutoring will be held, at this point in time, at Park Oaks Elementary School (1335 Calle Bouganvilla, Thousand Oaks, CA 91360). We may choose to expand to additional schools or locations at a later date.
- b. You agree to attend a minimum of 4 (four) hours per month. Tutoring is available between the times of 3:30 and 4:30, Monday, Wednesday, and Friday.
- c. You agree to arrive on time on your scheduled day, and not leave until 4:30, unless otherwise cleared by a T.O. Student Tutoring official representative.
- d. You agree to sign in and out, before and after tutoring.
- e. You agree to notify a T.O. Student Tutoring official representative in the event you cannot attend your scheduled lesson at least 24 hours in advance. Unless extraordinary circumstances arise, you must reschedule your lesson for another day that month.
- f. You agree to respect all students, teachers, staff, other tutors, and T.O. Student Tutoring employees. This includes properly spending time on education while tutoring, and refraining from using any behavior inappropriate for an elementary school campus.
- g. In the case of a legal pursuit resulting from your actions, you agree to indemnify and hold T.O. Student Tutoring harmless from any claim arising from a third party, regardless of T.O. Student Tutoring's association with that party. This indemnity includes third party references including in T.O. Student Tutoring works and T.O. Student Tutoring's use of any information supplied by you.
